T/C - Elijah - they have been in a relationship for 15 years but live separately although she stays with Elijah frequently. Elijah said Zoe's oldest son is Jamal but he doesn't have his number. He gave me her mother Ena's number - 07949 562 665.

T/C - Ena - phone switched off, answer machine

Seen at Walworth road Police Station with Dr Shukia s12 and Dr Utterson s12.

Background? taken from ePJS

Zoe Holder is a 47-year-old woman who has been known to SLAM from 2004 with a psychotic illness and forensic history. She was discharged from PCMHT-S in August 2022. She is currently prescribed Lurasidone. Partner contacted the police as Zoe has been acting erratically/aggressively and banging on his door. Police medin reports she is not taking her medication.

Her sons have recently contacted the crisis line raising concerns about her mental health.

Zoe was arrested for a Public Order offence ? fear/provocation of violence.
Zoe threatened to stash a victim with a knife in Tesco on Saturday. She also chucked chewing gum at the victim causing a red mark on their face. While in police custody the police reported she has been talking to herself and telling male police officers to come to her for sex.

While waiting for the doctors in the public entrance to custody I spoke to Zoe?s partner Elijah outside. Elijah said Zoe had been becoming unwell for some time and had been verbally aggressive towards him. He said an admission to hospital could be beneficial for her.

Interview
Zoe was guarded throughout the assessment but remained calm. She said she had ?stress and anxisty? but that was it and was not taking medication at the moment because it wasn?t being prescribed to her. She wants to go home and does not want to come into hospital as she ?has capacity she said.

She repeatedly responded with ?I am under duress and I want to go home?.

Zoe would not give us any details of her errest. She said she would engage with a mental health worker but did not want to take medication,

She was informed of the outcome of the assessment.

Reasons for decision

Zoe has a diagnosis of paranoid schizophrenia. She has a history of attempted murder in 2000. On
21/12/22 her partner contacted the police as she was behaving emutcally and was verbally aggressive
towards him. Her sons have also been concerned about her mental health. While in custody she has been sexually disinhibited and there have been concerns that she may be unwell.

On assessment today she presented as guarded. She could not explain why she was arrested. She does not believe she has mental health issues currently and does not want to take medication. She tacks insight into her mental health and tacks capacity to make docisions about her care and treatmen. There are concerns from people around her that she unwell and behaving in an aggressive manner. She has been arrested for threatening to ?slash? someons with a knife. Therefore she presents as a danger to those around her and needs to come into hospital for further assessment. There is no less restrictive option.

Outcome ? I was mindful to make en application for section however no bed was identified. Polica custody sergeant informed of this and medical recommendations left in police custody.

ARC have also been informed.

Discharge Plan

- As no bed available - Zoe was transferred from Welworth police station under S136
- Bed Identified and transferred to Bethlem Royal Hospital at 12:15 under S2 of the MHA
- Werd to notify GP on discharge with summary and plan.
